#### EXAMINATION FEES

The Faculty subsidises £270 of the first entry fee of undergraduates in full time education at the closing date, and GKT pays the balance for its SSM students. Candidates who withdraw from the examination after the closing date will trigger a forfeit fee as detailed below.

## WITHDRAWING FROM THE EXAMINATION
