VENUE AND CONFIRMATION OF ADMISSION TO THE EXAMINATION

An admission document confirming admission to the examination and giving details of the venue will be sent *only* when the casebook has been marked and assessed as meeting the required standard (see also paragraphs 9 and 10 of the Guide to the Diploma).

EXAMINATION FEE

The fee for the examination will be confirmed in August 2020, but will not be less than £805. The full fee must be received by no later than the date specified in the Examination Timetable above for an application to be fully valid.
