# **APPLICATION NOTES**

As applications are reviewed on a rolling basis (first come, first served) until the examination is full, candidates are advised to apply well in advance of the closing date for entries. The stated deadline is only the final date by which a completed application can be considered for entry to the examination; there is no guarantee that places will still be available at this time.

In the event that an examination is over-subscribed, we operate a waiting list. Candidates on the waiting list will be notified as soon as a place becomes available, and given a short period in which to respond. If candidates do not respond within this time, the place will be offered to the next person on the waiting list

An application is not complete until the due fee has been received.

Candidates whose employers are paying for their examination entry, and who therefore need an invoice from the Examinations Office to prompt the payment, should note that the fee must have been paid by the application deadline, and should plan well ahead accordingly.

#### **EXAMINATION FEES**

The fee for the examination is £700.

Re-entry fees are £360 for the written paper and £360 for the OSCPHE.

# WITHDRAWING FROM THE EXAMINATION

Candidates wishing to withdraw from the examination must notify the Examinations Office as soon as possible. The following withdrawal charges are applicable:
