EXAMINATION FEE

1. The full examination entry fee for all applicants is £1030 (online payment). Those students who have been awarded a bursary by the Faculty should contact the Academic Department for the relevant reduction (academicadmin@apothecaries.org).

WITHDRAWING OR DEFERRING FROM THE EXAMINATION

3. Candidates who wish to withdraw or defer from the examination must notify the Society. The following withdrawal penalties will be applied:

Timing of Application to Withdraw or Defer	Possible Refund (subject to approval)
Requests to withdraw or defer before the closing date for application	No fee.
Requests to withdraw or defer after the application closing date and 30 working days (6 weeks) before the examination.	Candidates withdrawing or deferring from an examination after the closing date and up to 6 weeks before the examination will normally be charged 25% of the fee.
Requests to withdraw or defer after the application closing date and 15 working days (3 weeks) before the examination.	Candidates withdrawing or deferring from an examination after the closing date and up to 3 weeks before the examination will normally be charged 50% of the fee.
Requests to withdraw or defer less than 15 working days (3 weeks) of the examination.	A refund will not normally be made to candidates withdrawing or deferring within 15 days of the examination. However, extenuating circumstance submitted with supporting evidence may be considered and subject to approval by the Head of Academic Department (HOAD).
